9.	<b>Neighbourhood Plan</b> The Clerk reported that grant funded expenditure has now been spent, although some work on reports cannot be completed until responses to the questionnaire have been sought and assessed. The costs of this work are included in what has already been paid.
	Developers have made undertakings in s106 agreements for two applications awaiting a decision notice for applications. Financial contributions have been drafted with a proportion agreed to be transferred to the Parish Council for future work on Neighbourhood Plan assessments of future infrastructure needs.
	Any additional expenditure for the work on the Neighbourhood Plan would require a recommendation from the planning committee and/or agreement by Full Council.
	There is no ongoing weekly support for the steering group and no date has been set for issuing the questionnaire to residents.
