Have your say on polling stations review

Uttlesford voters are being asked for their views on the polling districts and polling places that are used for elections in the district.

Each polling district has a designated polling place (a building such as a village hall where a polling station is located) for use on election days, providing suitable facilities which are accessible to all electors.

Like every local authority, Uttlesford District Council is required to review their polling districts and polling places every five years.

As part of the review, the council would like to hear from residents about their thoughts on the current polling districts and the suitability of the buildings and rooms that are used on election days for polling purposes.

Every effort is made to ensure that polling stations are accessible to all, and whilst it can be difficult to find the perfect premises and to secure permission to use them, the council aims to find the best possible solution.

Dawn French, the Returning Officer for the Uttlesford district and Saffron Walden parliamentary constituency, said: "We want everyone who is eligible to vote to be able to use their democratic right, and it is important that polling stations and districts are fit for purpose and meet the needs of electors.

"We would like to hear people's views on the polling places which have good accessibility and those that don't, and the reasons why. It would also be very helpful to hear suggestions about suitable alternatives."

NOTES

What are polling districts, places and stations?

Polling district – is a geographical sub-division of electoral area (or ward). An electoral area may be a UK parliamentary constituency (e.g Saffron Walden), a district ward, a county electoral division, or a parish or parish ward.

Polling place – is the area or building where a polling station is located.

Polling station – is where the voting takes place, for example a room (station) within a community centre (place). You can have more than one polling station in a polling place.
